



Frequently Asked Questions About BETTERCOIN Sales Delegation

How can I start being a BETTERCOIN Delegate?

You can start by learning about BETTERCOIN and its features, attending events and webinars organized by the Adoption partners. It's advisable to know how to use a digital wallet to be prepared for the upcoming economy; for BETTERCOIN, the recommended wallet is METAMASK due to its security and multitoken capability. In this wallet, you can train in using the Smartcoin BETTERCOIN, which is built under the multitoken concept, making it available only for wallets that handle custom tokens. Practicing in test environments like Sepolia will allow you to get familiar with the style of their transactions and features. Once you're properly trained, you can start selling on behalf of other users to earn 15% of the amount effectively paid by the buyer, 12% in ETH, and 3% in BETTER.

Are there any requirements to become a BETTERCOIN Sales Delegate?

None, just the desire to achieve financial freedom and utilize your sales skills to earn 15% of each sale made.

What is BETTERCOIN?

BETTERCOIN is the first smart cryptocurrency developed in Boston during 2022 that lives on the Ethereum main network and preferably uses the Metamask wallet. It incorporates new transactional intelligence technology, providing advanced security features for secure and efficient transactions, validating the delivery of BETTER and controlling the payment in ETH in each transaction. It uses a unique and innovative double transaction system, which ensures that payments are only processed once both parties confirm the transaction, meaning both have confirmed their part of the deal: delivery of BETTER by one party and payment in ETH by the other. If a buyer fails to make the payment, the owner can recover their Bettercoin by making a new transaction in which they send 0 BETTER, which is a recovery command (a very disruptive concept in the new internet of value). Bettercoin is the first digital asset that is impossible to manipulate, making it an excellent candidate for adoption.

What benefits does BETTERCOIN offer compared to other cryptocurrencies?

BETTERCOIN offers advantages such as transactional intelligence, greater security through a double transaction system, and the ability to authorize other Metamask wallets to sell on behalf of the owner, increasing liquidity and coverage beyond traditional web2



exchanges. BETTERCOIN is technology serving people, designed with the end user in mind, **User-centric approach**. BETTERCOIN is always in the owner's possession, in their digital wallet, and never in third-party hands; in the case of Delegates or buyers to whom the owner has transferred it, they are blocked and can be recovered if not paid in ETH.

What advantages does the BETTERCOIN Sales Delegation System offer?

The sales delegation system allows BETTERCOIN owners to authorize third parties to sell the cryptocurrency on their behalf without the worry of loss, speculation, or manipulation of the owner's asset. This system facilitates global transactions smoothly and securely, reducing costs and making it attractive for international trade.

What activities does a BETTERCOIN Sales Delegate perform?

The Delegate is responsible for educating potential future users about the advantages of Bettercoin, contacting them through their own means to sell Bettercoin; they can establish sales partnerships with companies in their own name, expand the market through digital marketing, provide support to their users, and participate in promotional events and activities. It is important for the Delegate to ensure that the buyer pays with ETH at the only BETTER payment platform, which is the **PayForBetter.eth** address in Metamask.

What is "transactional intelligence"?

Transactional intelligence is a technology that allows designing and building the new generation of smart cryptocurrencies called Smartcoin, which improve transparency and security in transactions between unknown parties. The main feature is that it connects non-consecutive blocks on the Ethereum Blockchain, making it an integral part of each transaction.

Will I have any contractual relationship with BETTERCOIN developers or Adoption partners?

The world of crypto-assets is a **space of freedom**. There is no contract with anyone. Selling BETTERCOIN is a personal activity that aims at financial freedom and rewards individual effort, your effort. The commission is part of the reward for being part of this global adoption. That reward is in ETH and BETTER.



What should I do about potential customers' distrust?

You can trust that your buyers (recipients of BETTERCOIN) are in a privileged position, at a time when this Smartcoin is priced low, similar to BITCOIN in 2009 when BITCOIN was unknown. BETTERCOIN has the advantage of being a currency that supports its price on the global demand for BITCOIN and ETHER, the two leading cryptocurrencies in capitalization, prices that together cannot be manipulated synchronously or permanently.

- Be part of early adoption to take advantage of all the growth.
- Buy growth and store of value for the future.
- This is a great opportunity to share the growth between owners and delegates.
- Monetize their sales management skills by working as a Delegate.
